San José Public Library Foundation Update presented by Executive Director Lucia Calve was accepted by the Commission.

Literacy and Learning Services annual updated was presented by Community Programs Administrator Pam Cornelison, Literacy Program Specialists Nick Hedrick (Alum Rock Branch) and Ofelia Chavarin (Hillview Branch) who serve as Family Learning Center Coordinators and was accepted by the Commission. VII. Library Director's Announcements (Jill Bourne):

- ***San José Public Library Volunteers Make Huge Impact at Beautify Your Branch Service Day***-The first-ever SJPL Service Day was a tremendous success. On **Saturday, January 21**, nearly **700 volunteers** joined together across San José to beautify their library. Volunteers completed a variety of projects that made their libraries a more welcoming, organized, and beautiful place. The Service Day was part of SJPL's [Volunteer Away Your Fines](#) program. Altogether, the volunteers

contributed a total of **1,300 hours** of service and **\$7,700 worth of fines were waived** from their library accounts allowing them to regain access to important services and resources. Many participants have already submitted positive feedback:

"My daughter and I both loved it. We learned more about the libraries resources while volunteering. An excellent way to spend a couple of hours on Saturday." - Jagdeep at the Village Square Branch Library.

- **Hillview Branch Library Celebrated its Ten-Year Anniversary** – Hillview Branch Library celebrated its 10th anniversary on **Saturday, January 28**, marking a decade of serving the community at its current location. The event kicked off with an Aztec dance performance followed by opening remarks from City Librarian Jill Bourne and Vice Mayor Magdalena Carrasco. The festivities included balloon twist performances, musical story time, family games, arts & crafts and cake & refreshments were donated from Mi Pueblo Foods.
- Due to the recent tragedy at Dr. Martin Luther King Jr. Library, security has increased its presence at the Library.
- SJPL Works will celebrate its grand opening on March 8th. It will be an evening event.
