The Library and Education Commission convened at 7:01 p.m. via Zoom webinar. Quorum was achieved with 10 Commissioners present.

II. Approval of Agenda

On the motion of Commissioner Allen, seconded by Commissioner Thorsen, the Commission unanimously voted to approve the February 17th, 2021 agenda.

- A. On the motion of Commissioner Allen, seconded by Commissioner Melillo, the Commission unanimously voted to approve the Minutes of the Library and Education Commission January 20th, 2021 regular meeting.

- V. Open Forum: No individuals addressed the Commission.

VI. Discussion/Action Items

A. Adopt Annual Commission Budget Position to Council (Sub-Committee/A. Maestre): Andrea Maestre, Administrative Officer, San José Public Library, provided an overview of the Annual Commission Budget Position Memorandum to City Council drafted by the Budget Sub-committee on behalf of the Commission. The memorandum focused on expanding library fines free to all materials, approving ongoing city funding for citywide digital inclusion initiatives, and maintaining current public service hours at all library locations. Discussion followed. Chair Mahaney-Gurahoo requested additional information be added regarding gender equity.

On the motion of Commissioner Trudell, seconded by Commissioner Jolly, the Commission unanimously voted to approve the draft with an amendment to include a statement about the importance of gender equity.

B. Update from Early Education Quality Standards (V. Kilambi/ A. Deglado-Ortiz): Received presentation from Araceli Delgado-Ortiz, Early Education Services Manager, San José Public Library, Nari Ferderer, Early Literacy Librarian, San José Public Library, and Laura Buzo, Recreation Superintendent, City of San José Department of Parks, Recreation, and Neighborhood Services (PRNS), regarding the annual report on the Early Education Quality Standards. Discussion followed. Ms. Buzo stated PRNS will continue to work with human resources to assess and develop early education qualifications for new staff positions at recreational preschool. Ms. Buzo and Ms. Delgado-Ortiz confirmed that virtual programs will continue after COVID-19 restrictions are lifted.

Sylvia Arenas, Councilmember, City of San José District 8, updated the Commission on priorities for her office.

VIII. Chair's Announcements:

Chair Mahaney-Gurahoo announced that teachers and childcare workers should be able to schedule the COVID-19 vaccination beginning February 28th, 2021.

IX. Library Director's Announcements:

Jill Bourne, Director, San José Public Library, provided information on the success of the Library's Holiday Laptop Donation Drive, the first Annual Virtual Winter Reading Program, the ability to now reserve SJ Access hotspots through the online catalogue, and the conversion of Lynda.com to LinkedInLearning still at no cost to San José Public Library members. Ms. Bourne also informed the Commission that the 2020 Impact Report will be shared with the public on the Library's website in the coming months.
