B. Education Strategy Annual Report (V. Kilambi)

The Commissions received a report on Education Strategy Annual Report from Division Manager, Vidya Kilambi, and Library Staff. They discussed the Library's comprehensive educational development areas.

- a. **Early Education** Entering school ready to learn and succeed.
- b. **Expanded Learning** Expanding education beyond the school day.

- **c.** College and Career Providing meaningful supports and opportunities on pathways to self-sufficiency.
- **d. Digital Literacy** Ensuring access, affordability, and adoption.
- **e. Adult Literacy & ESL** Developing and strengthening reading, writing, and English skills for adults to reach personal and professional goals.

A. Office of Councilmember Rosemary Kamei

Councilmember Rosemary Kamei provided an update from her office.

- Cross with the Councilmember: In collaboration with the Police Department, Councilmember Kamei, and schools during their walk- to-school event on October 9th. The event encourages safety while walking to school.
- Banned Books and Brews: Councilmember attended this event during banned book week, which was hosted by Clandestine Brewery in partnership with the Library.
- Mary Jane Hammon Park: Councilmember had a ribbon cutting at the park with students from Monroe Middle School in attendance.
- Climate Smart Youth Video Competition: There will be a screening of video submissions and awards ceremony in January 2026 at Council Chambers. Deadline to submit videos is October 31, 2025.
- On October 28, 2025, Council Agenda, the Council will be reviewing a memo to limit the use of City properties and facilities with recent concerns on immigration.

B. Office of Councilmember Pamela Campos

District 2 Councilmember Campos provided an update from her office.

• Mckinney Vento: In September, Councilmember Campos's Office authored a memo to include Mckinney Vento data among the relevant metrics to reduce homelessness. Mckinney Vento data is a way to understand how many students are experiencing homelessness in the community.

- Underutilized Private Lots: Council passed a memo for private lots that are underutilized to be used by small businesses.
- General Plan Review: Currently the focus is on the housing work. The task force will be meeting every month until June 2026.
