**A. Youth Commission Budget Summit Planning (Chair Kucharewski)**

  1. Inclusionary Housing Ordinance: Council will consider new an ordinance change. The current ordinance requires developers to include affordable housing during development. The new ordinance will require a lower amount of affordable housing from developers.
  2. Mobile Home Rental Ordinance: Council will consider changes to how much park owners can charge once a mobile homeowner sells their home.
- ii. Councilmember Campos is having an Early Childhood Education Townhall with Supervisor Ellenburg and Assemblymember Patrick Ahrens at Edenvale Branch Library on January 30.
