# A. INFORMATIONAL: 28th Street/Little Portugal Transit-Oriented Development (TOD) (A. Lopez, W. Hanson)

Woody Hanson presented on the 28<sup>th</sup> Street/Little Portugal Transit – Oriented Development (TOD). 28<sup>th</sup> Street/Little Portugal Station is one of four planned TOD stations in VTA's Bart Silicon Valley Extension Project. The TOD planned for this station aims to capture the cultural diversity of the area while meeting the needs of the community. The VTA have been collecting input from different community groups on what retail, businesses, and services should be at these TOD locations. The VTA requested Youth Commissioners to provide input what should be included at the 28<sup>th</sup> Street/ Little Portugal TOD location.

#### A. Office of City Manager Report (L. Buzo)

Laura Buzo, Assistant to City Manager, gave a brief update that the City is continuing to draft the master plan document. The City have been meeting with City staff, County representatives, community-based organizations, and school districts on how to effectively serve children and youths.

#### B. Council Liaison's Announcements (A. Dersh)

Alex Dersh, Council Assistant, shared announcements from the Council and their activities in last month. In the last month, Council voted to modify the revolving policy, voted to approve the Union and Labor negotiations, voted to modify building energy efficiency standards, voted to approve the Enhancing Youth Commission memo, accepted a report and recommendation from the San Jose Police, and accepted for the report on the City's long term trash plans.

#### C. Parks and Recreation Neighborhood Services (PRNS) Report (L. Hawkins)

Lauren Hawkins, Recreation Superintendent shared updates from PRNS from the previous month. PRNS has hired their first Racial Equity Manager, Veronica Amador Perez, to help guide the department to be more equitable in their services for the community. PRNS has some upcoming recruitments that are available on the PRNS web platform. Councilmember Torres presented a commendation to the former Recreation Superintendent, Ed Solist. Councilmember Foley and Dan presented a commendation recognizing our Disaster Service Workers for their service in providing disaster relief for our communities during the series of storms in early 2023. Within the Capital Division, there are some upcoming ribbon-cutting at the Heinlenville Park, Pellier Park, and a groundbreaking at the Flea Market Bruzzone and Mercado. Within the Recreation Division, there are events scheduled including the R.O.C.K Afterschool 15<sup>th</sup> Anniversary, Various Community Center Events, Fall Break Camps available across the City.

#### D. San José Library Report (M. Ornat)

Vidya Kilambi, Division Manager, shared updates from the Library. September 20<sup>th</sup>, the San Jose Public Library and San Jose State shared the 20<sup>th</sup> Anniversary of the Dr, Martin Luther King, Jr. Library partnership. In celebration of the anniversary, 10 new limited edition library card designs. The Library is hosting its' annual Fall into Fiction Short Story Contest 2023. In October, the Library is celebrating National Hispanic Heritage month and Digital Inclusion month. There are two new exhibits at King Library, World on the Move Exhibit and Pinoy Town.
