On the motion of Commissioner Khan, seconded by Commissioner Singh, the Commission voted unanimously to approve the items on the Consent Calendar.

V. Discussion/Action Items

A. Downtown Youth Wellness Center (C. Chun)

The Director, Cecile Chun, from the Alum Rock Counseling Center presented information on free services provided at the Downtown Youth Wellness Center (DYWC) for young people ages from 12-25 years old. DYWC is a partnership between the County of Santa Clara Behavioral Health Services and Alum Rock Counseling Center that provides an area with activities, hygiene, and mentoring/counseling services in pursuit of providing individualize support to youths. Discussion followed this presentation.

B. Fee Study Update: Parkland Dedication and Park Impact Ordinance (R. Ross)

The Planner IV, Rebekah Ross, from Parks, Recreation & Neighborhood Services (PRNS) presented about the Fee Study. Ms. Ross provided an overview of the Developer Impact Fee that developers are required to pay for any new development in San Jose. Developers may apply to lower the fees through a credit program. The Fee Study proposed the idea of providing a credit for developers if they create a public space that benefits the public with their development. There was one public comment. Discussion followed.

C. College & Career Readiness Report (A. Otte)

The Library's College and Career Readiness (CCR) Pathways Coordinator, Amanda Otte, presented an update on the College and Career Readiness programs from the Education and Digital Literacy team. Ms. Otte provided an overview on the quality standards, performance metrics, and coordination of all the College and Career Readiness programs. Ms. Otte requested establishing an Ad Hoc

Committee to partner with staff to evaluate ways to elevate youth voices. Discussion followed. On the motion of Commissioner Hoang, seconded by Commissioner Lee, the Commission unanimously voted to pass the motion for an Ad Hoc Committee.

D. YTRS YAC Social (M. Maloy)

Senior Library, Megan Maloy, announced as a part of the Youth and Teen Recreation Group for the South Bay Area, the Youth Commission is invited to the Youth Advisory Board Social. This social is for all Youth Commission, Youth Advisory Board, and Youth Committees to connect with other Youth Commissions with each other through activities and break-out discussion groups. PRNS will be opening the scholarship registration for eligible families to provide an opportunity for all youths and families to have access to programs.
