#### V. Discussion/Action Items

#### A. INFORMATIONAL: Think Hopeful (I. Choksy and. N. Raham)

Irem Choksy and Nadim Rahman from Think Hopeful gave a verbal report on the services of their organization. Think Hopeful is a mental wellness organization providing wellness support for youths in local community colleges and post-secondary success organizations. Think Hopeful is an online platform that offers multiple modalities of wellness which includes in 1:1 session, workshops/support groups, self-care resources, and social support. Think Hopeful's approach aims to make mental wellness stigma-free, accessible (24/7/365 services), offer social support, personalized, real-time support, and practical with coping tools for youths.

On the motion of Commissioner Bansal, seconded by Commissioner Lieu, the Commission voted unanimously to approve of Commissioners Lieu, Pradeepkumar, Mishra, Gonzalez-Muñiz, Mascarenhas to be members of the Civic Engagement Ad-Hoc.

#### VI. Reports and Information Only

#### A. Council Liaison's Announcements (A. Dersh)

Council Assistant, Alex Dersh, shared information about the Council item 7.2 on February 27, 2024, regarding the Raging Waters lease, assignment, and long-term request for proposal development. Raging Waters is a water theme-park owned by the City and located in Cunningham Lake Park in East San Jose, CA. It was leased to the company Palace Entertainment in 1995. In September 2023, Palace Entertainment announced it would end its agreement with the City and close the park ahead of the season Summer 2024. The City sought to have a new contract with outside company to continue operating Raging Waters as the City does not have capacity to operate the park itself. When the City seeks out a new contract, it puts out a Request for Proposal (RFP) which is a notice that the City is seeking bids for a new contract. The RFP outlines the details of what is needed and how the City will evaluate each bid.

City staff started developing a new RFP for a new park operator, outlining the guiding principles that they want to see in the new contract. Those guiding principles includes investments in capital, contribution in solving water quality challenges, and safe, affordable, quality experience for customers at the park. Additionally, staff outlined that Raging Waters should raise the local economy and community around the park.

Palace Entertainment ended their contract before the City could find a new operator for the park. In the interim, the City wants to assign a new company to operate the park until the new RFP can be completed for a long-term operating company. After evaluation of possible companies, staff determined that the company California Dream and Entertainment, Inc. is the highest rated applicant. Staff presented this in a memo at Council on February 27, 2024, requesting City Council to direct the City Manager to assign the contract to California Dream and Entertainment, Inc. and extend the agreement to another six months with an option for another six-month extensions. The Council voted with 9 votes in favor, 0 against, and 2 not voting.

#### B. Parks and Recreation Neighborhood Services (PRNS) Report (M. Mohammad)

Mo Mohammad, Interim Recreation Superintendent, shared updates from PRNS from the month.

- All community centers will be closed April 1<sup>st</sup> in observance of Cesar Chavez Day.
- There will be eight Egg Hunt events citywide. Registration can be completed through the PRNS city website or <a href="https://www.siregistration.com">www.siregistration.com</a>
- Recruitment is currently looking for part-time recreation leaders and lifeguards.
